

ORDINANCE No. 236

AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO REPEALING ORDINANCE NOS. 94 & 158, REPEALING CONFLICTING PROVISIONS, PROVIDING SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CLARK FORK, IDAHO THAT:

SECTION 1. Ordinance No. 94 providing for the construction and repair of sidewalks and the assessment of costs against the property in front of which said sidewalks shall be constructed, repaired or laid, enacted March 6, 1944, is hereby repealed in its entirety.

SECTION 2. Ordinance No. 158 relating to open burning, enacted December 11, 1970, is hereby repealed in its entirety.

SECTION 3. All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. If any section, paragraph, sentence or provision hereof or the application thereof to any particular circumstances shall ever become invalid or unenforceable, such holding shall not affect the remainder hereof, which shall continue in full force and effect and applicable to all circumstances to which it may validly apply.

SECTION 5. This ordinance shall be in full force and effect after its passage, approval and publication according to law.

PASSED AND ADOPTED by the Mayor and the City Council of the City of Clark Fork under suspension of the rule requiring three (3) separate readings this 22nd day of October 2003.


