AN ORDINANCE PRESCRIBING THE RATES TO BE CHARGED FOR THE USE OF WATER FURNISHED BY THE VILLAGE OF CLARKS FORK AND REGULATING THE MANNER OF SUCH USE; PROHIBITING THE WILFUL OR CARELESS INJURY OR DESTRUCTION OF ANY PORTION OF THE WATER WORKS OF SAID VILLAGE AND FIXING THE PENALTY THEREFOR.

Be it Ordained by the Chairman and Board of Trustees of the Village of Clarks Fork:

Section 1. That the rates to be charged for water furnished through the water works system belonging to the Village of Clarks Fork beginning July 1,1913, shall be as follows;

All persons carrying or in any way obtaining water from a neighbor's faucet, when the person so carrying is situated on the village main, \$1.00 per month.

When person carrying is not situated on village main 75¢ per month.

Section 2. The village shall tap the main and shall lay the necessary pipe to the lot line and the applicant, with the required application, shall deposit the sum of \$10.00 with the village clerk, said deposit of \$10.00 to be applied on water rent from date of installation.

Section 3. The rates herein prescribed shall be payable monthly in advance and shall be paid to the Village Clerk who shall account therefor as other moneys of said village.

Section 4.If the rentals herein prescribed shall not be paid, or if any subscriber using the water of said system shall for the period of thirty days be delinquent in the payment of the water rental due under the provisions of this ordinance, the said Village may shut off the water it had theretofore been furnishing and may refuse to furnish such service until such delinquent rentals are paid.

Section 5. Any person who shall wilfully or carelessly injury or destroy any portion of the works, fixtures or other property of said water system shall be guilty of a misdemeanor, and upon conviction thereof shall be fined in any sum not less than one hundred (\$100.09) dollars or imprisonment not less than thirty days in the Village jail or both such fine and imprisonment.

Section 6.0rdinance No.34, of the Village of Clarks Fork, entitled "An Ordinance prescribing the rates to be charged for the use of water furnished by the Village of Clarks Fork and regulating the manner of such use; prohibiting the wilful or careless injury or destruction of any portion of the water works of said village and fixing the penalty therefor," is hereby repealed.

This ordinance shall be in force and effect from and after its

passage and publication as required by law.
