The store plans to model after Yokes and Rosauers Supermarkets, complete with an inhouse butcher. Work is moving forward to redo the floors and ceiling as well as outdoor lighting features. She also expressed that if anyone had special requests for what should be stocked, to come on in and talk with her about it.
